HALL OF FAME NOMINEE CRITERIA

Inductee selection is made based on moral character, integrity, citizenship, record of local, national and/or international achievement, ability and recognition. The inductee must have conducted him/herself in such a manner as to reflect honor on the school and must have the qualities of character and standards of conduct found to be most desirable on one whom may be cited as an example for young people.

Nominees must meet one of the following prerequisites:

- Has graduated from Harlan High School
- Has been a faculty or staff member at Harlan High School
- Has been an administrator at Harlan High School

Individuals selected for induction will be invited to the Hall of Fame Induction Ceremony, which will be held at Harlan's 50th Year Anniversary Celebration on Saturday, September 26, 2009 at the Hyatt McCormick Hotel.

The following *must be completed* or the Hall of Fame Committee will not accept incomplete forms for consideration for the award:
